Sub : Post Retirement Medical Benefits Scheme

In partial modification to the Scheme for Post Retirement Medical Benefits, 2008, the Board of Directors, in its 250th Meeting held on 8-11-2012 has approved **enhancement of the ceiling limits for reimbursement of the cost of domiciliary treatment as indicated below :-**

Category	Existing ceiling for reimbursement/per annum	Revised ceiling for reimbursement/per annum
Employees who retired/separated before 1.1.1987	250% of Basic + DA +VDA drawn monthly on the date of cessation of service	350% of Basic + DA +VDA drawn monthly on the date of cessation of service
Employees who retired/separated between 1.1.1987 and 31.12.1991	175% of Basic + DA +VDA drawn monthly on the date of cessation of service	250% of Basic + DA +VDA drawn monthly on the date of cessation of service
Employees who retired/separated between 1.1.1992 and 31.12.1996	125% of Basic + DA +VDA drawn monthly on the date of cessation of service	175% of Basic + DA +VDA drawn monthly on the date of cessation of service
Employees who retired/separated between 1.1.1997 and 31.12.2006	75% of Basic + DA +VDA drawn monthly on the date of cessation of service	100% of Basic + DA +VDA drawn monthly on the date of cessation of service
Employees who retired/separated after 1.1.2007	75% of Basic + DA +VDA drawn monthly subject to maximum of ₹40,000/- on the date of cessation of service	100% of Basic + DA +VDA drawn monthly subject to maximum of ₹40,000/- on the date of cessation of service

Further, all retired/separated employees shall, however, continue to be permitted to take continuous treatment upto 1(one) year for a particular disease. In other words, the same prescription/advice of the doctor can be presented for reimbursement upto a period of one year.

This is in supersession to Circular No.P&T/01/057/88/1020 dated 11-3-2008.

The above modifications shall be effective from 1st December, 2012.
