The company was unlisted at that time and lot of shareholders were holding shares in Physical mode. For the purpose compliance of provisions of Rule 9A of the Companies (Prospectus and Allotment of Securities) Rules, 2014, bonus shares were issued in demat mode only. Shares of those shareholders holding shares in physical form were kept in a separate account i.e. "MSTC Limited Unclaimed Suspense Account". The shares are being transferred from that unclaimed account to the respective account of shareholders once the shareholders are being able to convert their respective holding from physical to demat mode. The shares are kept in unclaimed account to comply with the provisions of Rule 9A and may/may not be categorized as unclaimed shares under SEBI Regulations. However, as a good corporate governance measure we have incorporated the same in this report.
